### A MESSAGE FROM THE TREASURER

For the period through March 2019 our combined account balances stand at \$24,432. Compared with January 2019 at \$24,023. I want to give a sincere thank you to all of you who have donated to our organization.

This is a reminder to all of you to talk with your family and/or friends about your end-of-life wishes and desired funeral arrangements early on when things in your life are calm and not under duress (and give them a summary in writing). Here is why I say this: I am one of those people who is a life-long learner. When I learn new information that I feel will be helpful, I share the information with others. I have an interest in the end-of-life

experience and choices, because I want to experience this time in my life with the most control and contentment possible. Many people are afraid of these topics and try to avoid them. This is not helpful to you, and your family and friends who will be caring for you and/or making decisions and arrangements regarding you. The timing of these end-of-life and funeral discussions is important however. People will be most relaxed and receptive when they are not under duress themselves or facing the concerns that you wish to speak with them about. Talking to your sister about <u>your</u> funeral arrangements when her son was killed in a car accident several weeks ago maybe too painful for her to listen.

A few years ago, I spent a year studying topics like death, dying, grief, hospices, funerals, etc. After a time, I thought I should send an email to my 6 siblings mentioning my studies and certification and somewhat offering up my knowledge in the future if they had questions. I was busy and did not do it for several months. Just when I was ready to email them, I received an email that my brother had serious bladder cancer and was going to have his bladder removed. Oh, Oh, I thought.... probably not a good time to send this email because a discussion of death and dying may upset them. Later, I came across some very good information about Tidewell Hospice and all the services they provide, including services to Veterans. I was getting ready to email that information to my siblings (most in their 60s). Unfortunately, I received a call from my sister that my younger sister's 29 year-old son committed suicide due to his drug addiction. Oh Oh, .. another sensitive time about end-of-life and death, so not a good time to send hospice information around. Recently, I read the book called "Finish Strong" by Barbara Coombs Lee. It is about achieving an end-of-life experience to match the life one enjoyed - defined by love, purpose and agency. More good information that I want to share, but before I had a chance, I received another email that after a year of being cancer free (so he thought), my brother's bladder cancer metastasized to his brain and required surgery the next day to remove a 2" malignant tumor. It is an aggressive cancer and 50% likely to return even with radiation. Is he in the mood to read the book called "Finish Strong"? I am not sure, but I doubt it.

We don't always control the timing of things in our lives. When a serious disease manifests, or an unexpected death occurs, end-of-life issues like plans of care, urgent medical decisions, and funeral arrangements are more likely to be made in fearful, stressed, uncertain, chaotic circumstances. Illness and death are often heavy emotional times in a family. Prior discussion with family or friends should provide them the confidence, clarity and direction to handle decisions and care when the time comes. This should also keep the support and focus on the family member who is ill, or who passed away and should be honored in a meaningful way.

There may not be an optimal time to discuss end-of-life concerns, but don't wait until there is a crisis to initiate the conversation.

# **DID YOU KNOW?**

A 2017 study from the Bureau of Labor Statistics reveals the cost of dying—\$7,360 on average for funeral services and burial—has risen 227% since 1986 (compared to 123% for all goods). Today's \$14 billion death industry is catering to an increasing secular country: A 2017 survey by the National Funeral Directors Association found that only 39.5% of respondents are being buried in ceremonies with a religious component, and more than half of respondents are interested in green burial options and cremation. Remember, these costs exclude a burial plot, grave liner (almost universally required in FL), the cemetery grave opening and closing costs, and a gravesite marker.
