PRESIDENT'S MESSAGE - Summer 2021

Hello Members and Friends, since our last update we've added two new board members. Bo Galford as Board Secretary and Chuck Treadway as Treasurer. We appreciate their willingness to serve and share the load. Given the many challenges we have faced this past year, your Funeral Consumer's Alliance remains strong and relevant.

COVID 19 has affected many of us either through inconvenience or personal loss. Through May of this year, it was inconvenience for me, and then I lost a close friend to COVID. We had been best friends since 3d grade at Bay Haven Elementary here in Sarasota. He took the precautions, received his first vaccination within a week of infection. His wife and a daughter were also infected. After hospitalization at SMH (where he was born 63 years ago), he received all the therapeutic treatments, remained isolated and slowly declined. 42 days and he was gone. His spouse of 37 years was devastated. Along the way, she asked for advice on end-of-life planning. They had a living will but neglected to complete the DNR section. No cemetery plot planned. She asked for a Funeral Home recommendation. Since cremation was the best option, I suggested Your Traditions. She told me they were so kind and helpful at the time she needed help the most. That entire family is vaccinated now. My spouse, Dianna and I are test subjects in the Moderna Phase 3 trials. We were both vaccinated a year ago. We remain in the trial as they try and determine how long protection lasts. With new variants appearing all the time, choosing to remain unvaccinated is an unnecessary risk for you and those around you. Dianna and I are proof that the vaccine is safe and effective. Please get the vaccine for your protection and those close to you.

A MESSAGE FROM THE TREASURER

For the period January- June 2021, our contribution revenue totals \$1,815 and our new membership dues total \$310 for a grand total of \$2,125. New Service Record Update Options

As Nancie mentioned above, we have been processing many service record updates. One of our members, Catherine Dente, was waiting on an update form and decided to build her own. The result is a much-improved version that helps us capture more information that will assist your selected funeral provider and your family.

We are adding a self-service tab to our website at http://www.fcasarasota.com. The initial service record form, the update form and a digital version of our brochure/member application will be posted there in PDF format. Members can download, complete the form and mail it into Nancie. Once the forms are completed, we only want to work with paper. We don't want to put any member's personal data out on the web, even as an email attachment. We hope this self-service option will give you more control and you can share this with other prospective members. Thanks Catherine!

FEMA COVID FUNERAL EXPENSE REIMBURSEMENT

The Federal Emergency Management Agency (FEMA) has announced that it will begin applications for reimbursement for funeral expenses of deaths due to Covid. Here are some questions and answers. Please know that the details below are all the details we have. To check for updates to the program, <u>visit FEMA's</u> website. https://www.fema.gov/disasters/coronavirus/economic/funeral-assistance

Q: Who will qualify to have their funeral costs reimbursed?

A: Only those families/persons who experienced a death that was caused by Covid. Covid must be explicitly listed on the death certificate as the cause of death.

Q: Did the death from Covid have to occur within a certain time frame to qualify?

A: Yes. The death must have occurred after January 20, 2020. It appears this program will be available for Covid deaths throughout 2021 and beyond.

Q: Will FEMA advance me money upfront to pay for a Covid death funeral?

A: No. Do not contract for a funeral that you cannot afford, assuming that you'll get a grant to pay that funeral in time. You will have to pay for the funeral yourself first, in any case.

Q: How much will FEMA reimburse?

A: Up to \$9,000. But we are uncertain, as these reports contradict the language in the federal legislation that authorized this money. That legislation gives a different amount. We have not received an answer about this discrepancy.

NOTE!—FEMA will NOT reimburse funeral costs that you have already found money to pay for. For example, if you had a life insurance policy that covered part or all of the cost, or if you did a fundraiser to help pay for the funeral, or if you had a pre-need contract, you will not be reimbursed by FEMA for the money from the insurance (including pre-need) or the fundraiser.

Q: What agency should I call to start my application?

A: You must call FEMA's dedicated line, 844-684-6333. There is no online application. You must apply by phone.

Q: What should I do to prepare for filing my application?

A: We suggest you gather the following. This is advice based on our experience, but we do not know for certain what documentation FEMA will require.

- —A certified copy (not a photocopy, an official document from the vital statistics office in your state) of the death certificate. Remember that Covid must be explicitly listed as the cause of death.
- —A copy of the complete funeral contract, itemized bill, and documentation of any payment you made on that bill. For example, canceled checks, credit card statements, etc.
- —Documentation of any and all sources of money you received that helped you pay for some or all of the funeral. This includes things like receipts showing your fundraising total, or copies of any payments the deceased's life insurance company made toward the funeral.
