The office where your Final Arrangements files are kept, have agreed to provide the following services at the prices quoted.

1. Call for and pick up the remains in a 250 mile radius of any of the 7 Brewer & Sons Funeral Homes at quoted prices. \$2.50 per mile for pickup more than 25 miles one way.
2. Provide the necessary death certification and cremation/burial/transportation permits, which is usually obtainable within 72 hours.
3. Supply local news media with free obituary notices. Assist with any newspaper whether in state or out of state in addition to newspaper charges.
4. Assist in immediate arrangements for cornea transplant and/or tissue bank donations, should this have been the wish of the decedent.
5. Assist in arranging for and post-mortem examinations requested or ordered.
6. Under these low cost agreements, the price quoted must be paid in full to the funeral home within 48 hours from time of death by the person assuming responsibility for funeral cost.
7. Death Certificates cost varies per county and fees are set by each county and are subject to change at any time.

DISPOSITION OF REMAINS

Direct Cremation – Refrigeration of the remains as necessary to meet legal requirements, place remains in a minimum container required by the crematory, have the body cremated at the earliest time permitted after all paperwork is secure by law. Arrange for the crematory to dispose of the ashes, or return them to the family for other disposition. If the cremains are to be mailed, there is an additional charge for postage. -----\$950.00

Direct Burial – Holding, sanitation and refrigeration of remains as required by law or cemetery requirements, and delivery to the cemetery for private interment. There shall be NO PUBLIC VIEWING of the body of any funeral procession. The COST OF THE CASKET, CEMETERY LOT, VAULT, VAULT INSTALLATION, OPENING/CLOSING OF THE GRAVE SPACE ARE ADDITIONAL EXPENSES CHARGED DIRECTLY TO THE SURVIVOR. If prior cemetery arrangements have not been made, the funeral director will assist the family with necessary arrangements.. If the place of burial is beyond the 25 mile radius, extra travel is subject to \$2.50 per loaded mile.-----\$1,050.00

Direct Transfer – Embalm the remains, enclose in the minimum shipping container as required by regulations and deliver to the nearest rail or air freight terminal for out-of-state shipment. Transportation and final disposition expenses at destination charged directly to the survivor. -----\$1,100.00

Donation – After verifying acceptance with the Anatomical Board of Florida, execute the necessary papers, perform the required arterial emailing and deliver the remains to Gainesville, Florida for medical research at the College of Medicine. -----\$1,100.00

It is assumed that any desired memorial or funeral service will be arranged directly with the clergy of the family's choice, and that the remains will not be present at the service. Such service may be held in a church, private home or by an arrangement at the funeral home chapel at an additional charge. Any service provided by the funeral director in addition to those mentioned in this agreement must be specifically requested and individually contacted.

Funeral Consumers Association assumes no financial responsibility for the services of the funeral home or cemetery owners. Its sole function is seeing that the specific requests for the decedent are honored. Planned and pre-arrangements will prevent family survivors from having to make decisions under emotional stress that may be contrary to the wishes of the decedent.

1. Duration

This contract shall begin on October 1, 2022 and expires on October 1, 2027

2. Parties

The parties to this contract shall be Brewer & Sons Funeral Homes and Cremation Services and the Funeral Consumers Association of Tampa Bay, Inc (the association)

3. Terms

This contract shall be enforced for the full duration of stated herein provided that neither party violates and conditions listed below. Should either party violate any of these provisions, the offending party shall give the offended written notice of the violation and at the discretion of the offended party, require that such violation be rectified within 10 working days. If the offense is such that it cannot be satisfactorily rectified, the offended party may then give the offending party, in writing, by certified mail, a notice of cancellation, effective sixty (60) days from the receipt of notice. It shall be the right of each party to waive any conditions set herein in a manner that shall be acceptable to both.

- b. Sufficiency of services provided
- c. Solicitation of members by funeral home
- d. Use of another provided by Association
- e. Merger of Association
